

**NİTROMAK DNX KİMYA SANAYİİ A.Ş.**  
**DATA SUBJECT APPLICATION FORM**

**GENERAL DESCRIPTIONS**

Personal data subjects or their legal representatives defined as the data subject in the Personal Data Protection Law No. 6698 ("PDPL" or "Law"), are granted certain rights regarding the processing of their personal data in Article 11 of the Law.

Pursuant to the Article 13/1 of the PDPL; the applications regarding these rights to be made to Nitromak Dnx Kimya Sanayii A.Ş. ("**Nitromak**") who is the data controller, must be submitted in writing or by other methods determined by the Personal Data Protection Board ("**Board**"). Depending on the nature of your request; **it will be concluded in the shortest time possible or within thirty days at the latest upon receipt.** In case of a written response to the application, no fee will be charged for up to 10 pages, and for each page over 10 pages, the processing fee specified in Article 7 of the Communiqué on Procedures and Principles for Application to Data Controller may be charged. If the response to the application is given in a recording medium such as a CD or flash memory, a fee may be charged in the amount of the cost of the recording medium.

**APPLICATION METHODS:**

In this context, the applications to be made to **Nitromak** can be submitted to us by filling out this form and using one of the following methods:

- **Written Personal Application:** You may apply in person in writing with a valid identity document to Nitromak's address of "Via Flat İş Merkezi Beştepelер Mah. Nergis Sokak No: 7/2 Ofis No: 52 Söğütözü Yenimahalle Ankara",
- **Application via Notary Public: You may apply** by notification through a notary public to Nitromak's address of "Via Flat İş Merkezi Beştepelер Mah. Nergis Sokak No: 7/2 Ofis No: 52 Söğütözü Yenimahalle Ankara",
- **Application Via Registered Electronic Mail (KEP) Address:** You may apply by sending an email to the Nitromak's registered e-mail address of [nitromak@hs03.kep.tr](mailto:nitromak@hs03.kep.tr) (KEP), using a registered electronic mail (KEP) address and secure electronic signature or mobile signature.

It is recommended to write "Information Request Pursuant to the Personal Data Protection Law" on the application envelope or in the subject line of the e-mail for conclusion of your application in a short time. It is recommended to comply with the above-mentioned issues in the applications as much as the relevant method allows, as it will increase the probability of the application to be concluded positively and in a short time.
